Deposit Policy - first come = first confirmed

CANCELLATION POLICY. Cancellations and request for refunds must be received by telephone followed by immediate written notification. All documents or tickets issued by Princess Cruises and/or Kollander World Travel must be returned before refund can be processed. Should you have to cancel your cruise package, the following cancellation fees will be assessed:

Outside of 75 days prior to sailing date.....\$50.00 per person adm. fee
 74-31 days prior to sailing.....\$350.00 per person plus cost of airline ticket
 56-29 days prior to sailing.....50% of total cruise cost plus cost of airline ticket
 28-15 days prior to sailing.....75% of total cruise cost plus cost of airline ticket
 14 days or less prior to sailing.....100% penalty

In addition, no refund or adjustments will be made in the event of interruption or cancellation of the cruise by the passenger after the commencement of the cruise. It is highly recommended that passengers secure appropriate cancellation insurance through Kollander Travel. (Once issued, airline tickets are non-refundable.)

IDENTIFICATION. U.S. citizens must carry proof of citizenship in the form of a valid passport. Non-U.S. Citizens must carry a valid passport and appropriate visas. You will be denied boarding without correct identification.

TRAVEL INSURANCE. It is highly recommended that passengers secure appropriate cancellation/trip protection through Kollander Travel. Details on insurance coverage will be sent to you for online registration.

BAGGAGE. Neither Kollander Travel nor Princess Cruise Lines is responsible for or liable for damage, loss or theft of baggage or personal effects. We highly recommend purchasing travel insurance covering baggage.

SERVICES ABOARD SHIP. Valuables and personal funds should be placed in the safe in the Purser's Office. It is recommended that passengers carry traveler's checks and U.S. currency in small denominations. No personal checks are cashed aboard ship. Most major credit cards are accepted.

PHYSICAL DISABILITY. Princess Cruise Line reserves the right to revoke or refuse passage to anyone who may require treatment, care or attention beyond that which the ship's facilities can provide or whose mental or physical condition may make them incapable of voyage.

LAND ARRANGEMENTS. As a convenience to passengers, tickets to shore excursions, sports activities, and other services operated by independent

contractors may be purchased on board the vessel. These excursions are provided to you by other companies. Neither Princess Cruise Line nor Kollander Travel can be held liable for any delay, omission, act, injury, loss, incident or damage to you that shall prevent the successful operation of any shore excursion.

CRUISE AND AIR ARRANGEMENTS. Neither Princess Cruise Line nor Kollander World Travel operates, controls or supervises any airlines and neither will be responsible for airlines failing to meet schedules whether or not airline tickets were issued by Princess Cruise Line or Kollander World Travel.
